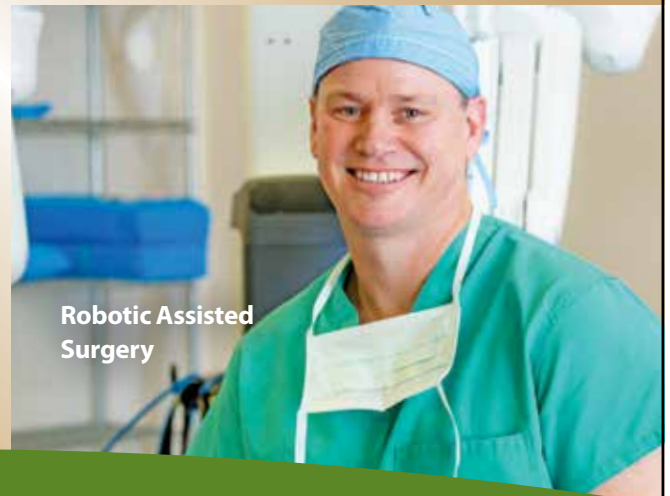

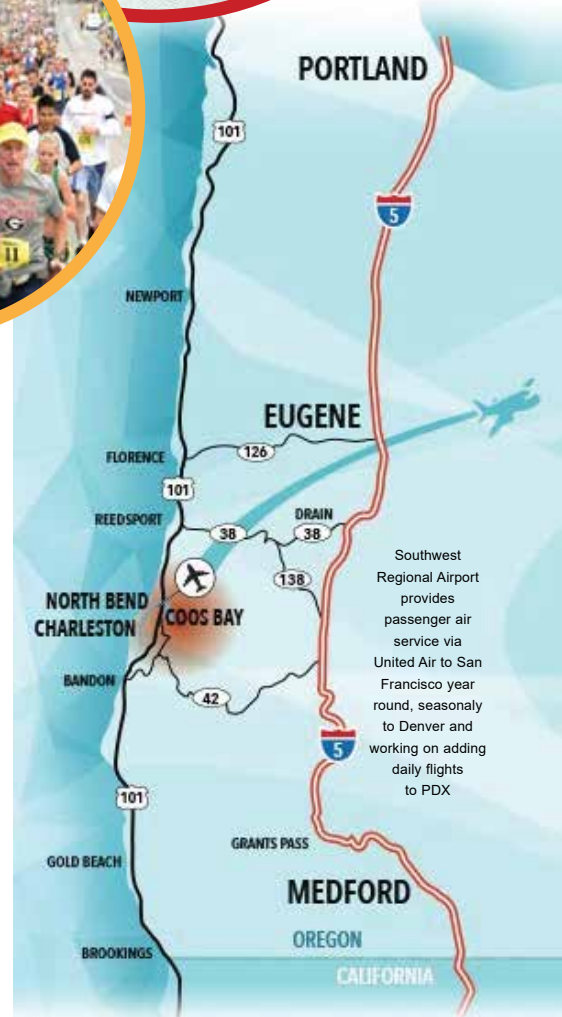
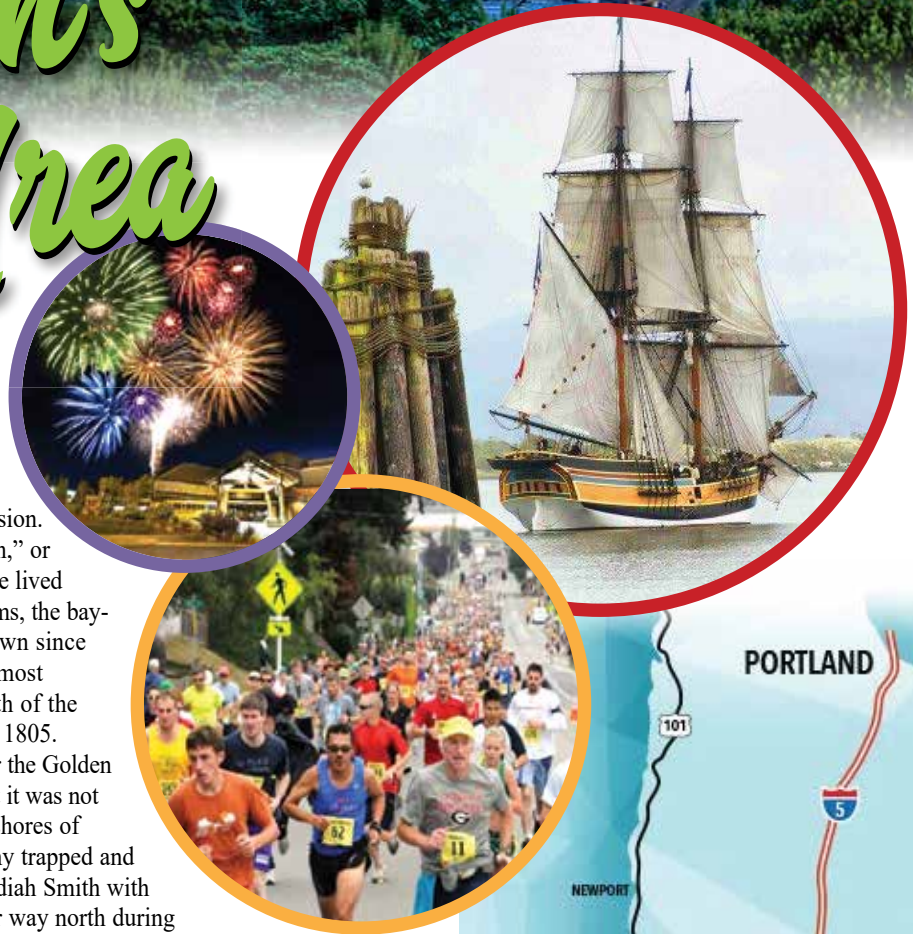

The origin of the name “Coos” is open to discussion. In the Hanis Coos Indian language, it meant “south,” or “southerner.” The Hanis and the Miluk Coos people lived from time immemorial along the sloughs and streams, the bay-shore, and the ocean beaches of what has been known since about 1850 as Coos Bay. They were the southernmost people known to the Chinook Indians at the mouth of the Columbia River who met with Lewis and Clark in 1805.

Sir Francis Drake is said to have found shelter for the Golden Hinde in the south cove of Cape Arago in 1579, but it was not until 1826 that Europeans actually set foot on the shores of Coos Bay. A brigade of the Hudson’s Bay Company trapped and traded for beaver furs during that winter, and Jedediah Smith with his fur company passed through Coos Bay on their way north during the summer of 1828.

Population growth came slowly, but was stimulated by extractive industries beginning with gold discoveries south of Coos Bay in 1853. Coal underlying the Coos Bay area was mined and shipped to San Francisco from 1856 until well into the twentieth century. The first two sawmills on the bay – the Henry Luse mill at Empire and the Simpson mill and shipyard at North Bend – began operations in 1856. Wood products were the mainstay of the economy and the greatest spur to growth during the twentieth century, especially after 1908 when the C.A. Smith Lumber Company opened the “largest sawmill in the world” at Bunker Hill. The economy also benefitted from specialty agricultural products such as apples, cheese, and cranberries. Maritime industries that grew included commercial fishing and oyster farming. Most recently the economy has become increasingly dependent upon the service trades – particularly government, medical, and education.

Coos County has a marine climate, mild and humid, a result of the moderating influences of the Pacific Ocean and from the rainfall induced by the coast range.

NORTH BEND

The city of North Bend was originally named Yarrow, possibly after the flowering plant, a river in Scotland or a vessel. The name reflects its geographic location at the north bend of the Coos Bay channel. Timber baron Asa M. Simpson and his son, Louis, were major players in the town's early development. With North Bend at the center of their vast timber holdings, the Simpsons built a number of large sawmills and shipyards. Another prominent figure was Vern Gorst, a member of aviation's Hall of Fame, whose land, water and air service provided the embryo of United Airlines. He was a major figure in the town's transportation improvement and expansion. Today, North Bend is home to 10,375 people and enjoys a diversified economy including a U.S. Coast Guard air station, Pony Village Mall (the largest enclosed shopping mall on the Oregon coast), dozens of restaurants plus antique stores and other unique shops throughout its downtown area. With historic and picturesque McCullough Bridge serving as the Bay Area's northern gateway on Highway 101, the city also welcomes travelers at the Southwest Oregon Regional Airport. The airport provides the region's commercial passenger and freight service, as well as general aviation facilities.

COOS BAY

Now the largest incorporated city in Coos County, Coos Bay was established in the 1850s as Marshfield, named for the Massachusetts birthplace of founder, J. C. Tolman. The town was incorporated in 1874, but in 1944 its name was changed to Coos Bay by a vote of the residents. Years later, the cities of Empire and Eastside merged with Coos Bay, and today all exist as one city. With a current population of 16,005, Coos Bay continues to be the commercial center of Oregon's south coast, with growing retail, service and professional economic sectors.

The downtown area is a popular stopping place for travelers using U.S. 101, the coast highway, which passes right through it. Visitors and residents alike enjoy strolling on the Coos Bay Boardwalk. They find treasures in our locally owned shops and restaurants.



CHARLESTON

Located where the ocean meets Coos Bay, the unincorporated community of Charleston is the area's commercial and sport fishing center, providing seafood processing and support services. The Charleston Marina Complex, operated by the Oregon International Port of Coos Bay, provides moorage for commercial and pleasure boats and can accommodate more than 550 vessels. Charleston is home to the Oregon Institute of Marine Biology and Charleston Marine Life Center and the U.S. Coast Guard Lifeboat Station. It is also the gateway to major recreation areas at Sunset Bay, Shore Acres and Cape Arago State Parks, Bastendorff Beach County Park and the South Slough National Estuarine Research Reserve Interpretive Center.

The Egyptian Theatre, home of the only originally installed Wurlitzer pipe organ left in Oregon, was restored to its former beauty by the City of Coos Bay and the Egyptian Theatre Preservation Association. In 2017, the Egyptian began showing feature films in stunning 4K ultra high definition. It is a unique, truly vibrant entertainment complex operated for the benefit of the greater Coos Bay area.



The Coos Art Museum has been a cultural focal point of Oregon's scenic Southern Coast since 1966 and features changing exhibits, a substantial Permanent Collection and art education workshops. Featuring a Steve Prefontaine memorabilia exhibit as well as local student art displays.



A well-established community theatre, North Bend's Little Theatre on the Bay, presents shows year-round including annual events like Lil Ole Opry, Haunted Theatre, Country Christmas and this year's show lineup including a musical.



Cruise into the past at the Coos History Museum, Oregon Coast Historical Railway Museum and Marshfield Sun Printing Museum in Coos Bay, the Bandon Historical Society, and Coos County Logging Museum in Myrtle Point.

FORESTRY & WOOD PRODUCTS

Coos County's 750,000 acres of forestland, owned by industry, families, and public entities, supply a highly diversified wood products industry. Soft and hardwood species are purchased by more than a dozen mills, exporters, and secondary processors operating in the county. Wood processors produce commodities (such as dimensional lumber and plywood) as well as specialty products (such as furniture-grade hardwood lumber, treated wood, and arrow shafts).

A steep reduction of the federal timber harvest in the early 1990s reduced the size of Coos County's forest industry. Today, the bulk of the county's timber production comes from sustainably managed private forests. Stability of current timber harvest levels, when coupled with the highly diversified suite of wood products manufacturers, ensures that forest products will continue to remain a vital industry in Coos County.
